

AGREEMENT

I have read and agree to the following:

1. **FORFEITURE AGREEMENT:** Vendor agrees to follow all instructions as given by Venice Pride organizers. Failure to do so may result in immediate termination of this agreement and forfeiture of any/all fees paid.
2. **SET-UP/TEAR DOWN:** Vendor must setup by 10:30AM on the date of the event. Arrival after that time will result in forfeiture of any/all fees paid. Please do not arrive before 8:00AM.
3. **SUBLETTING PROHIBITED:** No organization/business/individual may share/otherwise a registered vendor space. Doing so may result in forfeiture of any/all fees paid.
4. **PROHIBITIONS:** Vendors may not sell or give away merchandise beyond the scope of that which is the scope of your business/organization.
5. **DAMAGES:** Vendor acknowledges its liability, and agrees to compensate SunCoast MCC for any damages caused by, including but not limited to, its representatives, agents, employees, volunteers, members, vehicles, equipment, materials, etc. for any damage to persons or the property during the Venice Pride event.
6. **NO AMPLIFIED SOUND:** Any amplified sound from your space is prohibited.
7. **ONLY APPROVED FOOD/ BEVERAGE SALES:** SunCoast MCC reserves the right to approve all food/ beverage vendors for the Festival.
8. **VENDOR POSSESSIONS:** All vendor spaces must be staffed at all times. SunCoast MCC is not liable for any items left unattended.
9. **VENDOR PLACEMENT:** SunCoast MCC reserves the right to place vendors in any location on the Pride site.
10. **CLEAN UP:** Vendors are responsible for completely cleaning up any trash and/or debris on their space before leaving the premises.
11. **INSURANCE:** Vendors are responsible for maintaining adequate liability insurance or they may choose to "self insure," to cover any and all occurrences which may result in damage or injury to any person or person's property as the result of the Vendor's actions in their vendor space at Venice Pride.
